| Call to order | Meeting was called to order at 6:38pm. |
| Review/Approve <br> Minutes | May 12, 2014 Executive Committee Meeting minutes were discussed and approved. |
| Playground Update | The new South playground is currently being installed and is on track to be completed in <br> July so it will be ready for the Kindergarten Get to Know You days. Amy Kessler, a parent <br> in the outgoing 6 6 th <br> grade class contacted Royce about a legacy gift. They would like to <br> donate benches to add to the South playground. Royce sent them the link from the <br> company for them to figure out exactly what they would like to gift the school. He also told <br> them that they will need to consider shipping and installation costs when determining their <br> legacy gift. They are directed to contact Royce with what they want. Royce will follow up <br> with them this summer. <br> Cathy Boerner and Colleen Tadych are in the process of writing thank you notes to <br> families who have donated to the playground fund. Molly Carroll is in charge of ordering <br> the plaque. |
| Treasurer's Report | Notable changes since our last meeting: <br> REVENUE: |

- Alison added a line item called "Eat and Earn". We earned $\$ 91$ from our Qdoba night in May.
- There was an additional playground donation of $\$ 200$.
- Revenue from the Matty's card was about $\$ 1400$ for the year, which is $\$ 570$ less than budget. We are in need of a chairperson for Matty's for next year. Cathy Boerner asked Kara if she would like to be the Chairperson for Matty's Card for 2013-2014 and she accepted.
- Cubs on the Prowl revenue went down this year because they had more expenses and lower attendance compared to last year.
EXPENSES:
- The Building Equipment increased because we bought the paper roll for the teachers at the end of the year. The positive variance is because we thought we

|  | would have to pay tax, but that was not the case. <br> - High Interest Day usually breaks even but this year it made $\$ 500$. <br> - Home and School Office Supplies includes reimbursement to Nicole Patterson for the hallway display. Reimbursement for playground Thank You cards and postage will be coming. <br> - Sixth Grade Graduation: Home and School allotted $\$ 2625$. The $6^{\text {th }}$ grade class collected another $\$ 2600$. They had $\$ 5225$ to spend on their graduation ceremony. They spend almost $\$ 5000$. This doesn't include the $\$ 840$ collected for the class gift. The Graduation committee would like to add the extra $\$ 225$ that was allotted from Home and School to their Legacy amount. There was a discussion about Royce reported that the kitchen was not left in the exact same shape after the event and he was told that if we want to use it in the future we need to pay to have a food service worker there. Jane Ross told Alison Giese to look for an invoice from Raven Sports for the T-Shirts. <br> - Spirit Wear: Discussion of moving this line item to Revenue since it did net about \$370 each of the last two years. <br> - School Kidz: LouAnn Koppa reported to Colleen Tadych that there will be about $\$ 700$ profit for the 2013-2014 orders. In January LouAnn needed to commit to the upcoming school year. She was told by the Home and School Executive Committee to run the program at cost, but did it the profit way. Increased orders this year (140 ordered for 2013-2014 school year, 207 ordered for 2014-2015 school year) plus a $\$ 3-4$ profit margin per order resulted in the $\$ 700$. Colleen Tadych reported that when she ordered the $3^{\text {rd }}$ and $5^{\text {th }}$ grade kits recently, the cost was reasonable.
